You do not have to speak any Danish before signing a contract – English will do. Some healthcare roles may require a certain Danish proficiency level. In most cases, Danish classes are provided free of charge by your new employer as part of your contract. Most Danes speak English fluently, but learning Danish is necessary for all healthcare personnel, as clear communication is crucial in healthcare.

How do I obtain Danish authorisation to use my title?

In order to practice within your field of healthcare, you need to obtain Danish authorisation. You have to apply for authorisation with *The Danish Patient Safety Authority*, and the process varies depending on your specific profession and nationality. In any case, the process involves submitting documentation and, in some cases, undergoing exams or additional training.
